NARRATIVE

On October 30, 2024, I was assigned Department of Children and Families intake #2024-361928 for investigative purposes. The allegations were the offender (biological father [REDACTED]) watched [REDACTED] (victim) shower and would put his hands down [REDACTED] pants and fondled [REDACTED] bottom in the past.

On Tuesday, November 12, 2024, I spoke with Ms. Shannon D'Alessio ([REDACTED] mother). I scheduled an appointment for November 13, 2024 to speak with them in person.

On Wednesday, November 13, 2024, at approximately 0843 hours, Detective A. Sanchez #45385 and I conducted an audio recorded statement with Ms. S. D'Alessio. MS. D'Alessio advised she was married to the offender and finally divorced in 2019. They lived in Pennsylvania, New Jersey and New York before moving to Miami Florida in 2018-2019. Ms. D'Alessio disclosed incidents, that occurred to her 17 year old daughter ([REDACTED]) whom disclosed to a counselor that she found out through DCF. The incidents that occurred [REDACTED] with the allegations of fondling occurred in Pennsylvania and New York (refer to City of Miami Police Case #2401113-0077985). Ms. D'Alessio stated [REDACTED] told her, the offender made an inappropriate comment while at the pool, where he stated [REDACTED] could be his girlfriend, dressed in that bikini. Ms. D'Alessio advised [REDACTED] has never lived with the offender alone, advising [REDACTED] used to visit the offender ever other weekend, until the summer of 2024. [REDACTED] told her she was uncomfortable being around the offender. Since June of 2024, [REDACTED] has not gone over to see the offender.

At approximately 1018 hours, Detective Sanchez and I conducted an audio recorded statement with [REDACTED]. [REDACTED] knew the difference between a truth and a lie. [REDACTED] advised she last saw the offender after his wedding in Italy (which [REDACTED] attended/summer of 2024). She disclosed to her mother that she was uncomfortable being over his house. [REDACTED] lives primarily with her mother, her older sister ([REDACTED]) and the mothers husband and would visit the offender every other weekend. [REDACTED] disclosed to us when she was approximately 10 to 11 years old, the offender would call her into his bed to cuddle with her and while doing so, would place his hand underneath her underwear, towards the bottom rear of her buttocks, and placed his hand on her vagina. This would occur every weekend [REDACTED] would go over to visit. [REDACTED] denied any penetration. [REDACTED] felt it was normal because the offender would talk to her about it and normalize it. An other incident where [REDACTED] felt uncomfortable was a weekend near and or around her birthday in 2024. They went to the Four Seasons Hotel and [REDACTED] wore a bikini. The offender stated, [REDACTED] "looked like I could be his girlfriend" and [REDACTED] looked old enough to be his girlfriend. [REDACTED] has not seen or spoken to the offender since summer of 2024.

At approximately 1135 hours, I requested a complete criminal history check of the offender. There were no related charges.

At approximately 1152 hours, I showed [REDACTED] a single photograph at which time she positively identified as the offender.
